Terrace at Shafer's Mill Pool Open for Rentals

The terrace at Shafers Mill will be open for rental, not reservation, beginning August 1. So the last reservations will be accepted on July 23 for July 30. On Friday, July 18, members will be able to rent the Shafer's Mill Terrace during the pool season for a three hour block of time (10 AM to 1 PM, 1 PM to 4 PM, 4 PM to 7 PM) at a cost of \$75.

Rental forms will be available online and at the management office. The \$75 fee will cover supervision of the area and enforcement of the rental. The rental will be considered final when payment is received. Payment is not refundable, even if the facility is closed due to weather. During non-reserved times, residents are requested to remain on the terrace for no more than three hours at a time. Any unattended items will be removed from the terrace by pool staff. Adults over 21 only

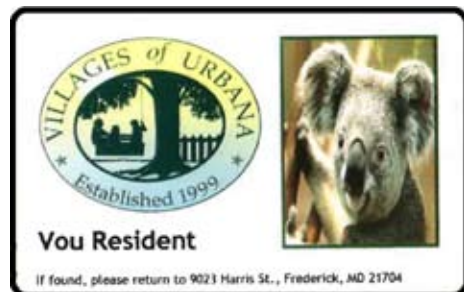
*Join us for an adults only event

Please remember that you must present a valid pass to enter the pool. If you do not have passes for your household, or have not updated them in 2014, please follow the link from the home page or contact the community manager at manager@villagesofurbana.net.

Parking near the pools is limited. Please remember to park in compliance with the law, at least 20 feet from intersections and not blocking driveways, mailboxes, or access. On our narrow streets, if someone is already parked on the other side of the street, please do not park opposite, as this could limit the ability of larger vehicles to move through the street.
