

Membership Pass Renewal

Believe it or not, just about 50% of the homes in the VOU have renewed their membership passes for the 2018 pool season. Over the next few weeks, everyone who has renewed will receive a personalized confirmation that the renewal has been processed. If you have not yet renewed, please do so as quickly as possible. Processing time is approximately 12 business days right now. All membership passes expire on May 1 UNLESS they are renewed.
