If you submit an electronic vote and your account is delinquent or if you are otherwise not in good standing as of 5:00 PM on Monday, November 7, 2016, your vote will not be counted.

The following are running for seats on the Villages of Urbana Community Association Board of Directors. There are two seats up for election. The term of service will be from the Annual Meeting 2016 to the Annual Meeting 2019.

Rick Boyle

Rick Boyle has served as a Vice President of Natelli Communities since 2003 and has served on the Association Board since November 2005. Rick is a certified public accountant and has been involved in the planning and development of Villages of Urbana going back to the late 1980's when the lands were owned by the Kiplinger Companies. Rick's primary focus is on management of financial and administrative issues related to Natelli's development activities in Maryland and Delaware. Rick is a member of the board of directors of the associations governing all of the communities under development by Natelli. He has actively participated in the financial oversight of the Association since joining the Board and has contributed to development of many policies used in the governance of the community. Rick has been nominated to run for a seat on the Board by Natelli Communities.

Condominium owner in the upper Midwest. Multiple-time homeowner, experience managing rental properties. Appreciation for maintenance of investment value. Tom Natelli

Tom Natelli is the CEO and principal owner of Natelli Communities, a privately held real estate investment and development concern with corporate offices in Gaithersburg, Maryland. The company and its affiliated entities, including Main Street Homes and Natelli Homes, are engaged in the acquisition, development and construction of master planned communities, principally in the mid-Atlantic region. The company has earned numerous industry and environmental awards for its development activities, including the ULI Award for Excellence for Large Scale Communities, Washington Metro Area Environmental Developer of the Year, and Suburban Maryland Builder of the Year. Notable projects include Avenel, Lakelands, The Villages of Urbana, Bay Forest, Sunset Island, Forest Landing and Urbana Corporate Center.

Mr. Natelli also serves on the boards of many non-profit organizations and business enterprises. Among his activities, he currently serves as Chairman of the Board of Chesapeake Lodging Trust, a self-advised, publicly traded, lodging REIT (NYSE:CHSP). He is currently Chairman of the Board of the School of Engineering at Duke University. He serves on the President's Council of Catholic Charities of Washington DC, and chaired the Catholic Charities

Gala for Washington DC in 2015 with his wife, Karen. He is a past Chairman of the Board of Suburban Hospital Healthcare System, and currently serves on the new building task force for Suburban.

Among his recent activities, Mr. Natelli served on the Board of Directors and was a member of the audit committee of Highland Hospitality Corporation (NYSE:HIH), a self-advised lodging REIT, until its sale to a private equity fund. In addition, Mr. Natelli served on the Board of Advisors of Fund 1 of The Halifax Group, a private equity fund. He was also cofounder and served as Chairman of the Board of eStara, a venture funded start-up that became a leading provider of VOIP based applications for web commerce, from 1999 until its sale to ARTG in 2006. ARTG was subsequently sold to Oracle.

Mr. Natelli served from 1993 thru 2003 on the Board of Trustees of Suburban Hospital Healthcare System, and as Chairman of the Board of Trustees from 2003 thru 2006, during which time he also headed the Executive Committee of the Board. An active community leader, he is a Past President of the Board of the Montgomery County Chamber of Commerce, and served as a member of the Financial Aid Initiative for Duke University. He played a central role in the organization of Montgomery Housing Partnership, which was created to preserve and expand the supply of affordable housing in Montgomery County, and served for several years on the Board of that non-profit organization. In addition he serves on the Boards of a number of community homeowner's associations under development by his company.
